An Enthusiastic Offer Of My Unique Skills And Expertise To Track Down Fraud And Corruption

Dear (New) Department of Government Efficiency (via @DOGE)
Dear Elon Musk (via @elonmusk) and Vivek Ramaswamy (via @VivekGRamaswamy),

This is in response to your post on X: “We are very grateful to the thousands of Americans who have expressed interest in helping us at DOGE. We don't need more part-time idea generators. We need super high-IQ small-government revolutionaries willing to work 80+ hours per week on unglamorous cost-cutting. If that's you, DM this account with your CV. Elon & Vivek will review the top 1% of applicants.” While the post has already received 22.2M views, I believe that my skills are still unique.

I am a trained mathematician and skilled computer scientist with a current interest in formal logic and theorem provers. I am also good with numbers and have always worked for my own small businesses.

As an enthusiastic consultant with a curiosity for financial engineering, I have designed & implemented query engines, reporting tools, and other components for trading systems at Fidelity Investments. Later, as the founder and sole developer for another software business of mine, I sold a fast, component-based server architecture for \$25M. I have spent the last 6 years honing my skills with deep learning networks in conjunction with also investing an inordinate amount of time into studying both state and federal law.

While I don't have adequate computing resources (due to my forced indigency; see my attached open letters/affidavits to top government officials and also posted at <https://femfas.net>), I have developed algorithms that I follow myself to seek out contradictions and inconsistencies in deceitful ‘legal text.’

Immediately following my attached open letter/federal affidavit to President-Elect Donald Trump, titled **“Forced Fatherlessness Is The Manifested Objective Behind The Child-Predatory ‘Feminism’ And Profiteering ‘LGBTQ+’ Dual Discrimination Schemes In Today’s Agenda-Driven Massachusetts,”** the federal appeal of my Civil RICO class action lawsuit was quickly terminated in Boston. This opened

up my next opportunity to finally take my now meticulously corrected *pro se* and *in forma pauperis* (grassroots) questions back to the U.S. Supreme Court. My prior SCOTUS petitions regarding the:

“The ‘Sec. 8. Affirmatively Advancing Civil Rights ... to prevent and address discrimination and advance equity for all’ clause of [President Biden’s] 2/16/2023 Executive Order results in Russell’s Paradox. As a logically unacceptable conclusion or deception, it must be corrected to a mere ‘equity for some.’ Can an Executive Order specifically ‘advancing equity for only some’ be Constitutional?” (SCOTUS No. 23-5932),

and the:

“Does sovereign immunity apply to an ‘LGBTQ+’ Massachusetts when using federal funds to subsidize the forceful separation and activist-agenda-driven alienation of innocent American children from their loving American parents?” (SCOTUS No. 23-6398)

questions were rejected apparently due to my underlying cases not explicitly formulating the questions.

I need to note that I am a law-abiding citizen and a **legal immigrant** from Romania. My family and I were granted political asylum in 1986 from a then-still communist tyranny. Massachusetts has been discriminating against me since 2011 due to my valid passport and projected “hidden Romanian assets.”

Due to the relentless discrimination and ruthless retaliation by this “LGBTQ+” tyranny, my accumulated in-arrears child support/expenses for my four dear children have reached \$415,000+, and no employer is willing to give me a job, as the state would put me in jail the next day. I have always diligently complied with all the court orders and my lawsuits have reached the point where the many “benevolent DEI layer” judges are now directly contradicting the nameless but ruthlessly punishing administrative “Deep State.”

I am a **forcedly indigent** *pro se* litigant and I continue to conscientiously apply for jobs as per the court orders (2,300+ applications so far). Nevertheless, I am not looking for legal assistance or monetary help.

I shelter in a tiny room in my now years-long house arrest. I love challenges, technology, and computers. I have the enthusiasm and seemingly limitless energy to put in 80+ hours per week of focused effort, and I am personally deeply invested in ferreting out all the fraud and corruption so prevalent in our judicial processes. I also have the experience of knowing where to look, and **I simply want to be useful again.**
