**APPELLANT'S STATUS AFFIDAVIT REPORTING ON THE PARALLEL  
FAMILY COURT BUNDLE E-FILED APRIL 27, 2026, AND HAND-  
DELIVERED APRIL 28, 2026, AND ATTESTING TO THE CHAIN OF  
CUSTODY OF APPELLANT'S APRIL 27, 2026, ADDRESS-UPDATE  
AFFIDAVIT (DOC 00118437697)**

I, Imre Kifor, the pro se Appellant in the above-captioned matter, declare and state under 28 U.S.C. § 1746:

**I. PURPOSE**

1. This Status Affidavit reports two events on the parallel Massachusetts state-court dockets that bear on the chain of custody of Appellant's April 27, 2026 Affidavit on the Updating of His Mailing Address of Record (filed in this Court as Doc 00118437697; Exhibit A as Doc 00118437698; Exhibit B as Doc

00118437699; all under Entry ID 6804893, Date Filed 04/27/2026), and on the parallel Family Court matters from which the underlying federal civil-rights record arose:

- (a) On April 27, 2026, Appellant e-filed a parallel Family Court bundle on dockets [REDACTED] and [REDACTED] / [REDACTED] via the Massachusetts Trial Court Tyler e-file system, contemporaneous with the federal e-filings in this Court and in D. Mass. No. 1:25-cv-11831-AK (Doc 36 / 36-1 / 36-2, Filed 04/27/26).
- (b) On April 28, 2026, Appellant hand-delivered, in paper form, the same content to the Register for the Middlesex Probate and Family Court at the Lowell Justice Center, 370 Jackson Street, 5th Floor, Lowell, MA 01852, in an envelope/paper box marked “Post-Hearing Motions” pursuant to Probate and Family Court Standing Order 2-99(a)(5).

## **II. THE APRIL 27, 2026, TYLER E-FILE CONFIRMATION**

2. The April 27, 2026, Family Court e-filing was confirmed by the Tyler system. The cover letter to the Family Court, with the Tyler envelope confirmations showing **Envelope Number 4871572** for case [REDACTED] (Kifor, Barbara Anne v. Kifor, Imre), and the parallel per-docket Tyler stamps on the WD filings (e.g., Envelope Numbers: 4871591/ 4871597 and “Date Filed: 4/27/2026 5:42 PM, Case Number: [REDACTED]”), are attached as **Exhibit 2**.

3. The two parallel Motions for Permission to File the attached Status Affidavit and Motion to Compel Decision (one captioned for the DV1 docket, and two for the paired WD dockets) are attached as **Exhibits 3-1 and 3-2**, respectively. Exhibit 3-2's last page bears the Tyler stamp identified above.
4. The Status Affidavit on the Federal Record Through 4/24/2026 and on the Updating of Father's Mailing Address of Record, in support of Appellant's three pending substantive motions in the Family Court, is attached as **Exhibit 4**. Its content recites the federal-court record through 4/24/2026, identical to the substance preserved in this Court's record at Doc 00118437697.
5. The Motion to Compel Decision on Appellant's three pending substantive motions, pursuant to Probate and Family Court Standing Order 2-99(c), anchored to this Court's presently binding 5/18/2026 appellees'-brief deadline, is attached as **Exhibit 5**.

### **III. THE APRIL 28, 2026, HAND-DELIVERY AND CHAIN-OF-CUSTODY**

#### **ACKNOWLEDGMENT**

6. The April 28, 2026, hand-delivery proceeded in the following sequence, which Appellant reports here on personal knowledge because it bears on the chain-of-custody acknowledgment that issued:

- (a) Upon Appellant's tender of the package, the Family Court clerk who attended the counter initially refused to accept any package containing exhibits “over-the-counter” without a court order.
- (b) Appellant then explained that Justice ██████████ had Allowed (without findings) Appellant's parallel post-hearing Motions for Permission on February 27, 2026, March 3, 2026, and March 10, 2026 (resulting in three substantive motions now pending merits adjudication on the parallel Family Court dockets), and pointed to the visible “Post-Hearing Motions” label affixed to the top of the package/paper box.
- (c) The clerk then left the counter to consult with another court official in a back room. Upon her return, the clerk informed Appellant that she would accept the package after all and accepted it.
- (d) Appellant then requested that the clerk sign the parallel Amended Hand-Delivery Certificates' Section IV acknowledgments, one for the DV1 docket and one for the paired WD dockets.
- (e) The clerk declined to give her name or to sign anything but offered to (i) handwrite the parallel docket numbers on the parallel “Acknowledgment by the Register” pages and (ii) apply the Office Stamp of the Middlesex Probate and Family Court Registry to each parallel certificate.

- (f) Appellant agreed. The clerk handwrote the parallel docket numbers ( [REDACTED] on the DV1 certificate and [REDACTED] / [REDACTED] [REDACTED] on the WD certificate) and applied the office stamp to each parallel certificate.
- (g) The clerk then assisted Appellant in photographing the two stamped certificate pages, which are reproduced as **the last two pages (pp 13–14) of Exhibit 1** below.

**IV. THE AMENDED HAND-DELIVERY CERTIFICATE (CHAIN-OF-CUSTODY ANCHOR)**

7. The Amended Hand-Delivery Certificate, executed by the Family Court Registry on April 28, 2026, as described in ¶ 6 above, is attached as **Exhibit 1**. The Certificate's Section II itemizes the 9-item, 793-page Family Court paper bundle delivered. The four larger exhibits, i.e., 8b to 8e, were drawn entirely from documents already filed and stamped in federal court and are reproduced here with the first two and the last pages, for length. The Certificate's Section III recites the parallel federal-court PACER / CM/ECF identifiers, including:
- **This Court (USCA1 No. 26-1346, Entry ID 6804893, Date Filed 04/27/2026):** Doc 00118437697 (Affidavit), 00118437698 (Exhibit A — Bristol Lodge intake), 00118437699 (Exhibit B — December 27, 2025 Verifying Affidavit).

- **D. Mass. No. 1:25-cv-11831-AK (Hon. Kelley, J.; Filed 04/27/26):** Doc 36 (Affidavit), 36-1 (Exhibit A), 36-2 (Exhibit B).
- **D. Mass. (MBD) No. 1:26-mc-91166-DJC (Hon. Casper, Chief J.):** mailed paper packet of 4/27/2026 (CM/ECF stamp pending; Appellant has no pro se e-filing privileges on the MBD docket).

8. The Family Court Registry's office stamp on Exhibit 1's parallel acknowledgment pages, together with the underlying federal PACER / CM/ ECF stamps recited in Exhibit 1's Section III and visible on the federal-court face of the exhibits referenced therein, collectively establish that the same content was contemporaneously placed in the federal court records on April 27, 2026 and accepted by the Family Court Registry on April 28, 2026.

#### **V. EFFECT ON THIS COURT'S RECORD**

9. The April 27, 2026, address-update affidavit (Doc 00118437697 in this Court) is now reflected, by the parallel state-court paper companion described above, on the parallel Family Court dockets. Appellant's mailing address of record, **Bristol Lodge Men's Shelter, PO Box 541095, Waltham, MA 02453**, is consistent across this Court, the District Court, the MBD docket, and the Family Court.
10. The clerk's pre-acceptance refusal of the over-the-counter delivery, her subsequent acceptance after back-room consultation, and her refusal to identify

herself or to sign the acknowledgment are reported here for completeness.

Appellant does not move for relief on this record in this filing; the report is provided so the Court has the full chain of custody for the address-update affidavit.

12. Service is by electronic mail due to forced indigency, which the U.S. District Court (Hon. Angel Kelley, J.) adjudicated on March 25, 2026, by allowing Appellant's motion to proceed in forma pauperis in No. 1:25-cv-11831-AK.
