IMRE KIFOR'S STATUS AFFIDAVIT ON DELIBERATELY INDUCED EXISTENTIAL EMPLOYMENT, HEALTH, AND HOUSING CRISIS

NOW COMES the Petitioner, ("Father"), and states:

- 1. Father has been consistently alleging a retaliatory conspiracy to silence and enslave by the Respondents.
